NOTICE OF INTENTION TO REPEAL DESIGNATION

TAKE NOTICE THAT the Council of the Corporation of the City of St. Catharines intends to repeal the designation under the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as follows:

1317 Pelham Road (Brown-Jouppien House)

The subject lands, known municipally as 1317 Pelham Road, are located on the north side of Pelham Road, east of Fifth Street Louth, and are described as CON 8 PT LOT 3 30R-8613 PART 1 as in RO402479; St. Catharines.

The purpose of repealing the existing designation by-laws is to adopt a new heritage designation by-law to re-designate the Brown-Jouppien House, at 1317 Pelham Road, as the existing designation by-laws for the property, under Part IV of the Ontario Heritage Act, are out of date in terms of both content and format. The new designation by-law would follow the best practices in the heritage field in terms of the content and format of the property's Statement of Significance.

The house was originally designated based on its extensive architectural features in the Loyalist Georgian style, alongside its historical significance as the home of John Brown, the oldest house in the City of St. Catharines and operation as one of Niagara's early taverns and inns on the Mohawk Trail.

Notice of Objection to the repeal of the designation may be served on the Clerk of the City of St. Catharines within 30 days after the date of publication of this Notice of Intention in a newspaper having general circulation in the Municipality. NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the City of St. Catharines intends to designate property to be of cultural heritage value or interest under the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as follows:

1317 Pelham Road (John Brown House)

The subject lands, known municipally as 1317 Pelham Road, are located on the north side of Pelham Road, east of Fifth Street Louth, and are described as CON 8 PT LOT 3 30R-8613 PART 1 as in RO402479; St. Catharines.

The property demonstrates several features demonstrating cultural heritage value or interest.

With its Loyalist Georgian style, including its symmetrical five bay facade and wide centre hall plan, the John Brown House boasts significant architectural features. It remains the only Niagara house built entirely with Reynales Rockway Dolomite limestone.

Relating to historical significance, the John Brown House is the oldest house in the City of St. Catharines, and one of the few remaining United Empire Loyalist homes in Niagara. The land was originally settled circa 1785 by John Brown, a Butler's Ranger of German descent from the Schoharie Valley. The grand, two-storey Georgian house, which incorporated the first 1.5-storey structure, was constructed prior to Brown's death in 1804.

The house served as an early Niagara tavern and inn, which opened under the sole ownership of Brown's son Adam in 1809. Its location on historical routes and roadways, including the Mohawk Trail and Brown-Decew Road, contributed to its use and value as a stop on the Dundas-Niagara Stagecoach Line. The house remained a tavern until at least the late 1830s.

A more detailed Statement of Significance can be obtained from the Planning and Building Services Department.
