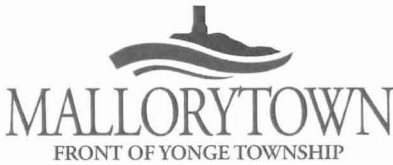

**A BY-LAW TO REPEAL BY-LAW #20-87, BEING A BY-LAW TO  
DESIGNATE MUNICIPAL HERITAGE PROPERTY**

**WHEREAS** the Council of the Corporation of the Township of Front of Yonge supports the request of the St. Paul's Presbyterian Church to repeal the municipal Heritage Designation passed by By-law #20-87.

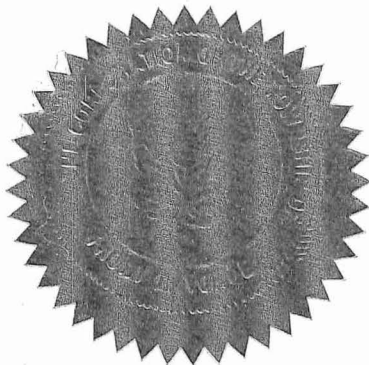
**AND WHEREAS** no objections were received;


