### THE CORPORATION OF THE TOWN OF WINGHAM

BY-LAW NO. 1863(1986)

## By-law to Designate 13/15 Patrick Street East, in the Town of Wingham.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O., 1980, Chapter 337, authorized Council of a Municipality to designate property within the Municipality to be of historic value or interest;

AND WHEREAS the Clerk of the Town of Wingham has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of the Ontario Heritage Act, R.S.O., Chapter 337;

NOW THEREFORE, the Municipal Council of the Corporation of the Town of Wingham enacts as follows:

- 1. The property described in Schedule "A" attached hereto, is hereby designated to be of historic and architectural value and interest.
- 2. Section 33 of the Ontario Heritage Act, R.S.O., 1980, Chapter 337, shall apply only to the following structure on the said property.
- 3. The municipal Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described above in the proper Land Registry Office.
- 4. The Clerk is hereby authorized to cause a copy of this By-law to be served on the Ontario Heritage Foundation and to cause Notice of the passing of this By-law to be published in the same newspaper having general circulation in the Municipality once for each of three consecutive weeks.
- 5. This By-law shall come into effect on the final passing thereof by the Council of the Corporation of the Town of Wingham.

TOWN OF WINGHAM

In the Town of Wingham, in the County of Huron in the Province of Ontario being composed of:

FIRSTLY: The Westerly 13.75 feet through-out from front to rear of Lot 1 on the West Side

of Centre Street, Plan 415 for the said
Town of Wingham;

SECONDLY:

The Easterly 59 feet through-out from
front to rear of Lot 1, on the East Side
of Josephine Street, Plan 415, for the said

THIRDLY:

The Easterly 59 feet of the Southerly
27 feet of Lot 2 on the east Side of Josephine
Street, Plan 415 for the said Town of Wingham.
