Notice of Intention to Repeal Designating By-law 194-93 1679 Blair Road

TAKE NOTICE that the Council of the Corporation of the City of Cambridge intends to repeal designating By-law 194-93 at 1679 Blair Road, the former Nicholson's Tavern, now Lambs Inn, a property of historic and architectural significance under Part IV of the Ontario Heritage Act, R.S.O. 1990, Ch.0.18. The subject property is within the area proposed to be designated as a Heritage Conservation District under Part V of the Ontario Heritage Act. By-law 194-93 is to be repealed to allow for the designation of the subject property in accordance to Part V of the Ontario Heritage Act.

ANY PERSON MAY, within thirty days of this publication of this notice, send by registered mail or deliver to the Clerk of the City of Cambridge, notice of his or her objection to the proposed repealing of the designating By-law 194-93 together with a statement of the reasons for the objection and all relevant facts. If such a notice is received the Council of the Corporation of the City of Cambridge shall refer the matter to the Conservation Review Board for a hearing.
