

Dear Sir

On Wednesday, September 7th, 1983, pursuant to Section 29.6 of the Ontario Heritage Act, Deep River Council passed By-Law 17-83, designating as heritage property ten buildings located on land now known as King's Farm. For your information, a copy of the By-Law is enclosed. The By-Law includes the reasons for the designation.

In the first instance, this By-Law was published for only one week; it was subsequently published for three consecutive weeks. Hence the change in the last date for filing objections.

CORPORATION OF THE TOWN OF DEEP RIVER

BY-LAW NO. 17-83

A By-Law to designate certain properties
in the Town of Deep River under The
Ontario Heritage Act.

WHEREAS Section 29 of The Ontario Heritage Act, R. S. O. 1980,
Chapter 337 makes provision for the designation of property within a
municipality of historic or architectural value or interest;

AND WHEREAS the Local Architectural Conservation Advisory
Committee of the Town of Deep River has recommended to Council that
certain properties within the Town merit designation;

AND WHEREAS the Council of the Corporation of the Town of
Deep River has given due notice to designate the hereinafter mentioned
properties;

WHEREAS the last date for filing objections was Aug. 15, 1983;

AND WHEREAS no objection has been received to the said desig-
nation by the Clerk or by his office;

NOW THEREFORE the Council of the Corporation of the Town of
Deep River ENACTS AS FOLLOWS:

1. That the hereinafter described property be, and is, hereby designated
to be of historic or architectural value or interest under the
Ontario Heritage Act, for the reasons hereinafter stated:
 - (a) 612 Highway 17 East - With the exception of a recently erected
modern frame building, the group of ten buildings owned by Atomic
Energy of Canada Ltd. and located on a parcel of land known
locally as King's Farm, and comprising Range A of each of Lots 41
and 43, part of Lot 42, part of Lot 44, and part of Lot 45,
formerly of the Township of Buchanan, now in the Town of Deep
River.

Historically, this farm is probably an authentic example of the
type of property and buildings used as a stopping place in the
Ottawa Valley during the heyday of the lumber trade. Architec-
turally, the buildings form a very well preserved group of
typical mid to late 19th century, squared-log structures,
unique in their proximity to the Trans-Canada Highway.
