### **Reasons for Decision:**

The application as proposed meets the intent of the Official Plan, and Zoning By-law and is appropriate development for the subject lands. Any written and verbal public input received was fully considered as part of this decision.

### **Conditions:**

- 1. That the applicant provide the Secretary/Treasurer with deeds in triplicate for conveyance of the subject parcel, a registrable legal description of the subject parcel together with a copy of the deposited reference plan, if applicable, for the issuance of the Certificate of Consent.
- 2. That the final certificate fee, payable to the Town of Grimsby be submitted to the Secretary/Treasurer.
- 3. That all conditions of consent be fulfilled within two (2) years from the date of the notice of decision pursuant to Subsection 53(41) of the *Planning Act*, failing which this consent shall be deemed to be refused.
- 4. Subsection 3 or 5 of Section 50 of the *Planning Act* R.S.O 1990, shall apply to any subsequent conveyance or transaction involving the severed land.
