## Re: Notice of Decision of Demolition Request The Ontario Heritage Act, R.S.O. 1990, C. O.18

TAKE NOTICE that the Municipal Council of The Corporation of the City of London, at the Council Meeting on April 4, 2023 **CONSENTED subject to terms and conditions** to the application made under section 34 of the *Ontario Heritage Act* for a permit to remove heritage attributes from the property at 247 Halls Mill Road. The resolution from council is enclosed for your reference.

An owner of property who wishes to appeal Council's decision may do so by giving notice of appeal to the Ontario Land Tribunal (OLT) and the City Clerk within **thirty days** of publication. The notice of appeal shall set out the objection to the decision and reasons in support of the objection. I hereby certify that the Municipal Council, at its meeting held on April 4, 2023 resolved:

That, on the recommendation of the Director, Planning and Development, with the advice of the Heritage Planner, the request to remove heritage attributes from the property at 247 Halls Mill Road, pursuant to Section 34(1) of the *Ontario Heritage Act*, BE APPROVED subject to the following terms and conditions:

a) the use of machinery be prohibited in the demolition or removal of the accessory building's debris;

b) the existing brick and rubble stone foundation shall be retained and be protected in situ until Municipal Council decision following receipt of the recommendation of the Conservation Review Board; and,

c) the removal of the debris be completed in accordance with the demolition plan on file with The Corporation of the City of London;
