NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of The Town of Carleton Place intends to designate the building at the following municipal address as a property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, 1980, S.O. Chapter 337(29).

LEGAL DESCRIPTION OF HUGH WILLIAMS RESIDENCE

The tract of land and premises being composed of Lot 6, Pt Lot 5, Section L, Plan 258, 222-224 William Street in the Town of Carleton Place

REASON FOR DESIGNATION

This house is significant for its front porch which has very elaborate woodwork. There is also a flower pattern wrought iron cresting around the top of the bay window, and a glassed in porch which also sports much elaborate woodwork. The house occupies one whole lot and half of another which back onto the Mississippi River

The lots were purchased from a CPR conductor, Robert Cramm, in 1893 by Hugh Williams, a lumber agent, and his wife, Margaret. They built the house in 1895 and sold it in 1902 to F. H. Brown, a miller. In 1905 the house was sold to Samuel Allen, a printer and co-editor of the Carleton Place Herald for many years.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Town of Carleton Place, notice of his/her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Carleton Place shall refer the matter to the Conservation Review Board for a hearing.
