NOTICE OF PASSING OF DESIGNATION BY-LAW

**Designation of Properties by Municipalities for Addition to the
Municipal Heritage Register
as a Designated Heritage Property
under Section 29 in Part IV of the Ontario Heritage Act**

*City of Timmins By-Law 2024-9026
Designate 220 Algonquin Blvd E as Cultural and Heritage Property*

Location: 220 Algonquin Boulevard East, Timmins

Notice is hereby given that the Council of the Corporation of the City of Timmins, at its meeting held on September 3, 2024, passed the following by-law to designate the identified property as being of Cultural Heritage Value or Interest under Part IV, Section 29 of the Ontario Heritage Act, R.S.O., c 0.18.

By-Law 2024-9026 – 220 Algonquin Boulevard East

Any person who objects to the by-law may appeal to the Ontario Land Tribunal by giving the Tribunal and the City Clerk, within 30 days after the date of publication of this notice, a notice of appeal setting out the objection to the by-law and the reasons in support of the objection, accompanied by the fee charged by the Tribunal.

Notices of appeal to the by-law are to be submitted to the City Clerk by registered mail or dropped off at Service Timmins, 220 Algonquin Boulevard East, Timmins, ON, P4N 1B3 before 4:30 p.m. on October 14, 2024

BY-LAW NO. 2024-9026

Being a by-law to designate the property at 220 Algonquin Boulevard East, City of Timmins as being of cultural heritage value or interest.

WHEREAS the *Ontario Heritage Act*, R.S.O. 1990, Ch. 0.18 Section 29(1) authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of cultural heritage value or interest;

AND WHEREAS authority was granted by Council to designate the property at 220 Algonquin Boulevard East as being of cultural heritage value or interest;

AND WHEREAS Council caused notice of its intention to designate the property to be given to the owner of the property and to the Ontario Heritage Trust and further, has caused the notice of intention to be published in the Timmins Daily Press, being a newspaper of general circulation in the municipality;

AND WHEREAS no objections to the notice of intention to designate were received;

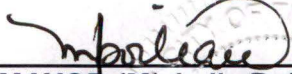
AND WHEREAS Council has described the Property, set out a statement of cultural heritage value or interest for the Property, and described the heritage attributes of the Property in Schedule "B" to this By-law, which forms part of this By-Law;

NOW THEREFORE the Council of the Corporation of the City of Timmins enacts the following as a By-law:

1. THAT the property located at 220 Algonquin Boulevard East, more particularly described in Schedule "A" attached to this by-law, is designated as being of cultural heritage value or interest.
2. THAT the reasons for designation are set out in Schedule "B" attached to this by-law.
3. THAT the City Clerk is authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" to this by-law in the land registry office.
4. THAT the City Clerk is authorized to cause a copy of this by-law to be served upon the owners of the property at 220 Algonquin Boulevard East and upon the Ontario Heritage Trust and to publish notice of this by-law in a newspaper having general circulation in the municipality.

READ a first and second time this 3rd day of September, 2024.

READ a third and final time and enacted and passed this 3rd day of September, 2024.

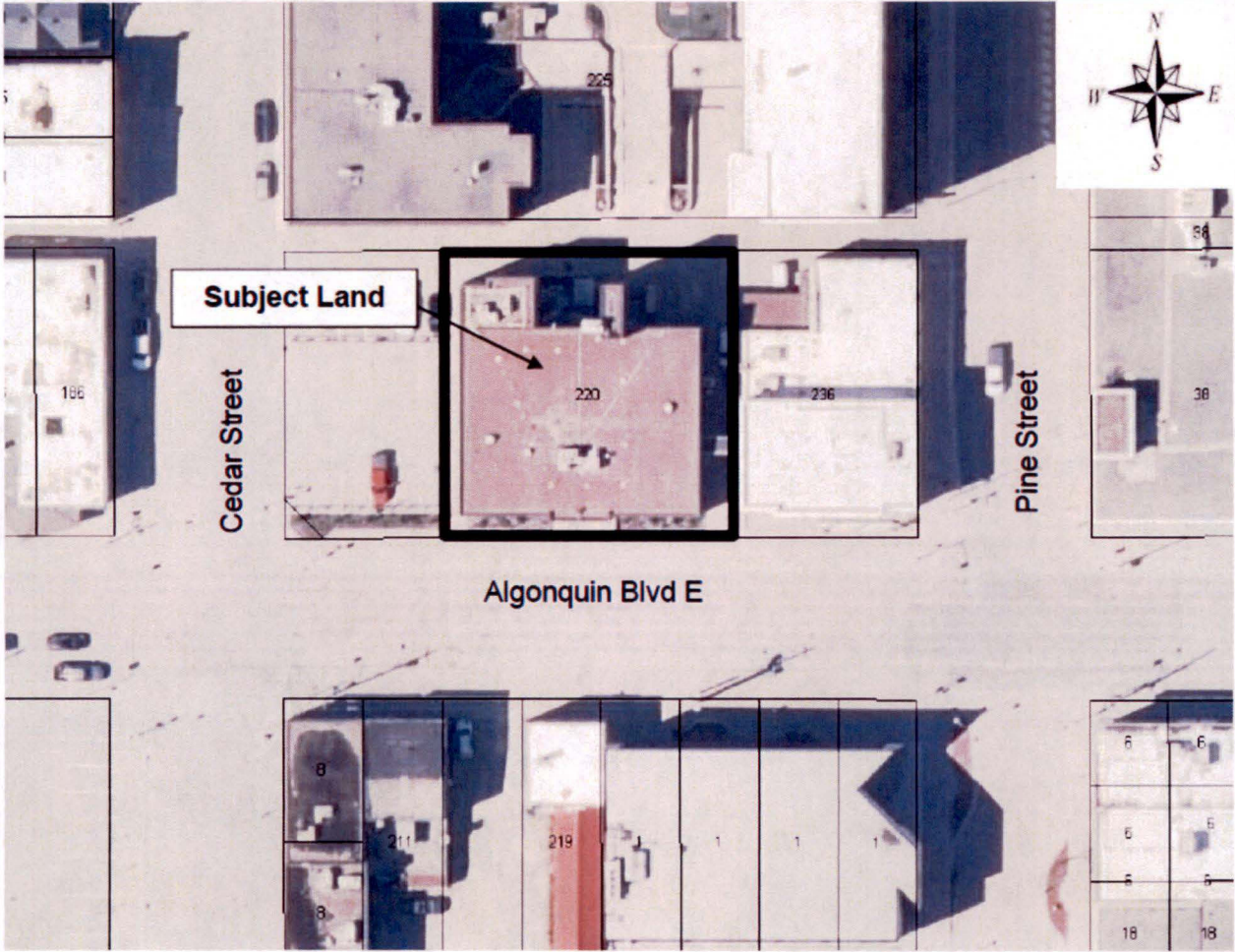

STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST:

Assessment of cultural heritage value or interest with reference to criteria as set out under O.Reg 9/06:

The property has design or physical value because;	
It is a rare, unique, representative or early example of a style, type, expression, material or construction method;	YES
It displays a high degree of craftsmanship or artistic merit;	N/A
It demonstrates a high degree of technical or scientific achievement.	N/A

- Elements of the art deco style are reflected in the symmetrical treatment of the façade, stone trim, relief, shadow lines, vertical windows and decorative elements that are centered around the main entrance.

The property has historical or associative value because;	
It has direct associations with a theme, event, belief, person, activity, organization or institution that is significant to a community;	YES
It yields, or has the potential to yield, information that contributes to an understanding of a community or culture;	YES
It demonstrates or reflects the work or ideas of an architect, artist, building, designer or theorist who is significant to a community.	YES

- The building has been home to municipal government since 1938, and is associated with key moments in the development of the City of Timmins and the early Timmins townsite prior to amalgamation.
- The building reflects the vision of the early residents, and contributes to a better understanding of the community and culture.
- The building was designed by P. J. O’Gorman, who established a practice in Northern Ontario. Active from 1914 to 1961, O’Gorman received dozens of commissions across the North, including the Timmins Municipal Building and St. Anthony’s Roman Catholic Cathedral. Further, the building was constructed by Hill-Clark-Francis, a northern-based contractor associated with early development in Northern Ontario.

The property has contextual value because;	
It is important in defining, maintaining or support the character of an area;	YES
It is physically, functionally, visually or historically linked to its surroundings;	YES

- The building is situated adjacent to the City of Timmins Engineering Building (old Post Office), St. Mary's Gardens (old St. Mary's Hospital), and is across the street from the building which originally housed the offices of the Porcupine Advance. St. Anthony's Roman Catholic Cathedral is located one block to the north and together, these buildings reflect early planning and development in establishment of the Timmins townsite.
- The building is intended as a landmark due to its function, architecture and location.

DESCRIPTION OF HERITAGE ATTRIBUTES:

- Face-brick detailing on face of the building.
- Symmetrical arrangement and proportion of window openings.
- Original stonework at roofline and around the entrance to the building.
- The central entrance and staircase (as feature of the interior and exterior arrangement).
- Terrazzo flooring to second floor and on the central staircase.
- Plaques mounted to outside of building.
