## **BY-LAW NO. 2013-78**

A BY-LAW TO REPEAL BY-LAW NO. 84-172, "A BY-LAW IMPLEMENTING THE MARKET SQUARE HERITAGE CONSERVATION DISTRICT PLAN AND DESIGNATING THE MARKET SQUARE AREA OF THE CITY OF KINGSTON AS A HERITAGE CONSERVATION DISTRICT".

**PASSED:** April 11, 2013

**WHEREAS** it is Council's intent to replace and re-designate the Market Square area as a Heritage Conservation District and adopt a new Heritage Conservation District Plan, pursuant to Sections 41 and 41.1(2) of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18; and

**WHEREAS** Council has consulted with its Municipal Heritage Committee regarding the passing of this By-law.

**NOW THEREFORE BE IT RESOLVED,** The Council of The Corporation of the City of Kingston hereby **ENACTS** as follows:

- 1. To repeal By-law No. 84-172, "A By-law Implementing the Market Square Heritage Conservation District Plan and Designating the Market Square Area of the City of Kingston as a Heritage Conservation District";
- 2. This By-Law shall come into force and take effect on the date of its passing.



MARK GERRETESEN MAYOR NOTICE OF PASSAGE OF A BY-LAW TO DESIGNATE THE MARKET SQUARE AREA AS A HERITAGE CONSERVATION DISTRICT AND TO ADOPT THE MARKET SQUARE HERITAGE CONSERVATION DISTRICT PLAN 2013, PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT (R.S.O. 1990, Chapter 0.18)

**TAKE NOTICE** that the Council of The Corporation of the City of Kingston on April 9 & 13, 2013 passed By-law No, 2013-78 under Sections 41 and 41.1 of the <u>Ontario Heritage Act</u>, R.S.O. 1990, Chapter 0.18, to repeal By-law No. 84-172 and designate the Market Square area as a Heritage Conservation District and adopt the Market Square Heritage Conservation District Plan 2013. The lands affected by this by-law are defined in the Key Map below and include all those properties facing Springer Market Square on Ontario, Market, King East and Brock Streets.



AND TAKE NOTICE THAT any person may appeal to the Ontario Municipal Board in respect to the passing of this By-law, by filing with the Clerk of the Corporation of the City of Kingston within 30 days of the first publication of this notice. A notice of appeal, setting out the reasons in support of the objection, accompanied by the prescribed appeal fee(s), by certified cheque or money order made payable to the Minister of Finance is required.
