



"SCHEDULE A"

To By-Law No. 13 for 1982

FOR THE CORPORATION OF THE TOWN OF CLINTON

The following property, including lands and buildings is to be designated as being of architectural and/or historical value or interest, under Part IV of the Ontario Heritage Act, R. S. O. 1980, Chapter 337.

(e) Former Carriage House of the Irwin-Gunn Estate - 200 High Street.

Plan 339, Pt. Lots 1232, 1233 and 1236, the boundaries of which parcel being more particularly described as follows:

Commencing at a point on the North Limit of Lot 1232 distant Twenty-five and five tenths (25.5') feet Westerly from the Northeast angle of Lot 1232; THENCE Westerly along the Northerly limit of Lot 1232 a distance of Twenty-four (24.0') feet to a point distant Thirty-two and Six tenths (32.6') feet Easterly from the Northwest angle of Lot 1232; THENCE Southerly parallel to the Westerly limit of Lot 1232 and distant Thirty-two and Six tenths (32.6') feet Easterly therefrom a distance of Two Hundred and Eight (208.0') feet to a point Fifty-six (56.0') feet North from the South limit of Lot 1236; THENCE Easterly parallel to High Street and Fifty-six (56.0') feet Northerly from the South limit of Lot 1236 a distance of One Hundred and Seventy-one and three tenths (171.3') feet to a point One Hundred and Sixty-five (165.0') feet Westerly from East Street; THENCE Northerly parallel to East Street, Seventy-six (76.0') feet to the Southerly limit of Lot 1234; THENCE Westerly along the South limit of Lot 1234, Forty and nine tenths (40.9') feet to the Southwest angle of Lot 1234; THENCE Northerly along the East limit of Lot 1233 a distance of Seventy-nine (79.0') feet; THENCE Westerly parallel to High Street a distance of One Hundred and Eight (108.0') feet to a point, the said point being distant Twenty-five and five tenths (25.5') feet Westerly from the East limit of Lot 1232; THENCE Northerly parallel to the East limit of Lot 1232 a distance of Fifty-three (53.0') feet more or less to the point of commencement of the parcel herein described.
