BEING A BY-LAW TO REPEAL BY-LAW NUMBER  
86-230 (HO-1), BEING A BY-LAW TO DESIGNATE  
A MUNICIPAL RESIDENCE IN THE TOWN OF GEORGINA  
AND/OR BUILDING OF HISTORIC AND ARCHITECTURAL  
SIGNIFICANCE.

WHEREAS the Council on December 11th, 1987, pursuant to  
Section 29 (6) of the Ontario Heritage Act designated St.  
Andrew's Presbyterian Church, 20858 Dalton Road, Sutton; Part  
of Lot 17 and 18, Block 69, Plan 69 as being of historical  
architectural value or interest.


AND WHEREAS the owners of St. Andrew's Presbyterian  
Church pursuant to Section 32 (1) of the Ontario Heritage  
Act have requested that Council repeal the said by-law.

NOW THEREFORE the Council of The Corporation of the  
Town of Georgina enacts as follows:

1. THAT By-law 86-230 (HO-1) being a by-law designating  
St. Andrew's Presbyterian Church of architectural  
value and/or historical value or interest, the real  
property and exterior of the property know municipally  
as 20858 Dalton Road and more particularly described  
in Schedule "A" attached hereto is HEREBY REPEALED.
2. The Clerk is hereby authorized and directed to cause  
a copy of this by-law to be registered against the  
property described in Schedule "A" attached hereto in  
the Land Registry Office.
3. The Clerk is hereby authorized and directed to cause  
a copy of this by-law to be served upon the Owner of the  
property and upon the Ontario Heritage Foundation and  
to cause a notice of this by-law to be published for  
three consecutive weeks in a newspaper having general  
circulation in the Town of Georgina



SCHEDULE "A" TO BY-LAW NO. 86-230 (HO-1)

DESCRIPTION OF ST. ANDREW'S PRESBYTERIAN CHURCH

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Georgina in the Regional Municipality of York (formerly in the Village of Sutton in the County of York) and being composed of the North forty one feet (41') throughout from front to rear of Lot Seventeen and Lot Eighteen in Block Number Sixty-nine in the said Town according to the registered Plan thereof Number Sixty-nine identified as roll number 080-808 according to the Assessment Rolls.

**REASONS FOR DESIGNATING ST. ANDREW'S PRESBYTERIAN CHURCH**

**HISTORICAL:**

The Church was built in 1864 at the Innisville 6th line and Highway 11 and at that time it was known as the "6th Line Presbyterian Church". In the early 1900's a new church was built and the 6th Line Presbyterian Church was closed to regular services. In 1925 a group of Presbyterians under the leadership of the retired Minister J. D. Campbell acquired the property on Dalton Road to build a church and later purchased the "6th Line Presbyterian Church" building. The Presbyterian congregation then dismantled the 6th Line Church, labelling each part and hauled the pieces across the ice of Lake Simcoe with teams of horses reconstructing the Church at its present site. The doors of the St. Andrew's Presbyterian Church opened in late 1927 and the first marriage ceremony to occur in the Church was that of Mr. & Mrs. Irving Robertson, owner of the Toronto Evening Telegram.

**ARCHITECTURAL:**

The design of the Church consists of a basement under a wood frame structure with a steep sloping roof. A square norman style bell tower is also the main entrance and the interior of the Church is simple and spartan and unchanged to the present.

Much of the 6th Line Church stands as the original structure including the frame, plaster on lath walls, wood floors, and windows with the fieldstone on the exterior being added later.

**SPECIAL INTEREST:**

A large wooden chair situated behind the alter bears the following inscription on its underside:

"Made in 1901. Solid olive wood from Mount of Olives, near the Garden of Gethsemane, Palestine. Brought to Canada from Jerusalem 1901 by J. Ross Robertson.

Presented to St. Andrews Presbyterian Church, Sutton West, Ontario, Christmas 1927 by Irving E. Robertson"
