## NOTICE OF INTENTION TO DESIGNATE A PROPERTY SECTION 29 OF THE HERITAGE ACT

**TAKE NOTICE** that the Council of the Corporation of the Township of Champlain intends to designate the property bearing the civic numbers 59 Court Street, 1023 and 1027 Queen Street, described as Lots 7, 8 and 9, south side of Queen Street, on Plan Number 15, occupied by the Court House, L'Orignal Old Jail House, and the administrative offices of the United Counties of Prescott and Russell for its historical and architectural value and interest.

THE CULTURAL HERITAGE VALUES AND INTERESTS of the property are as follows: Built in stone and designed in the Loyalist manner, the building occupied by the Court House, L'Orignal Old Jail House, and the administrative offices of the United Counties of Prescott and Russell is the oldest in Ontario as well as being the oldest continuous use of a building for municipal facilities. It has participated in all of the changes affecting judicial administration in Ontario since 1824. This building, with its cupola, is distinctive of the history and development of the village of L'Orignal, now part of Champlain Township.
