DESIGNATION BY-LAW 140-2024 PURSUANT TO THE

**Re: Notice of Intent to Amend the Heritage Designation By-Law 140-2024 for 1078 Major Mackenzie Drive West, pursuant to Part IV, Section 30.1 of the *Ontario Heritage Act*.**

**INTENT TO AMEND A DESIGNATION UNDER THE *ONTARIO HERITAGE ACT***

Please take notice that the Council of the Corporation of the City of Vaughan intends to amend a heritage designation by-law, under Part IV, Section 30.1 of the *Ontario Heritage Act*, being By-law 140-2024 to the property municipally known as **1078 Major Mackenzie Drive West** in the City of Vaughan, in the Province of Ontario.

**REASON FOR AMENDING THE DESIGNATION**

The proposed amendments to By-law 140-2024 are recommended to further detail the discrete area of cultural heritage value within the broader property.
