

## THE CORPORATION OF HALDIMAND COUNTY

By-law No. 899/08

Being a by-law to designate certain attributes situated on a parcel of land on the Seneca River Range Pt. Lot 14 on Haldimand County Road 54, in the former Regional Municipality of Haldimand-Norfolk now in Haldimand County, in the Province of Ontario, as being of historical value or interest

WHEREAS Section 29 of <u>The Ontario Heritage Act</u>, R.S.O. 1990, Chapter 0.18, authorizes the council of a municipality to enact by-laws to designate property, including certain attributes of the real property thereon, to be of cultural heritage value or interest;

WHEREAS the Council of The Corporation of Haldimand County has caused notice of intention to be served on The Ontario Heritage Foundation and upon the owners of the lands and premises known municipally as Seneca River Range Pt. Lot 14 on Haldimand County Road 54, in the former Regional Municipality of Haldimand-Norfolk now in Haldimand County to designate property including real property thereon as being of cultural heritage value or interest;

WHEREAS the Council of The Corporation of Haldimand County has caused such notice of intention to be published in a newspaper having general circulation in the municipality for one week;

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of Haldimand County within the time prescribed by the said statue;

AND WHEREAS the reasons for designation are set out in a Schedule "A" attached hereto;

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- 1. THAT the Young Memorial Plaque and certain attributes situated on a parcel of land on the Seneca River Range Pt. Lot 14 on Haldimand County Road 54, in the former Regional Municipality of Haldimand-Norfolk now in Haldimand County, and being described more particularly in Schedule "A" attached hereto and forming part of this by-law, is hereby designated to be of cultural heritage value or interest.
- 2. THAT a copy of this by-law be registered in the land registry office against the Young Memorial Plaque and certain attributes located on a parcel of land on the Seneca River Range Pt. Lot 14 on Haldimand County Road 54, in the former Regional Municipality of Haldimand-Norfolk now in Haldimand County as described more particularly in Schedule "B" attached hereto and forming part of this by-law.

3. AND THAT the Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property (Roll #2810.152.002.06510.0000) and on The Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the municipality of one week.

READ a first and second time this 10th day of March, 2008.

READ a third time and finally passed this 10<sup>th</sup> day of March, 2008.

## Reasons for Proposed Designation

This section of land beside the Grand River was granted to Adam Young and his family for their loyalty to the Crown during the American Revolution. Adam and his sons John, Daniel and Henry fought with the Butler's Rangers and Mohawk Chief Joseph Brant in defending Canada. Upon this tract of land, eldest son John Young was the first white settler to start a new life post war in 1783. The family has erected a plaque to commemorate this history and has requested formal designation under the Ontario Heritage Act.
