

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Haldimand intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

- (a) Former St. John's Anglican Church Parish Hall  
Plan 216, Lot 2 East Front Street in the Town of Haldimand in the Regional Municipality of Haldimand-Norfolk, in the Province of Ontario, formerly the Township of Seneca.

Reasons for Proposed Designation

- (1) The Parish Hall was built about 1845-46, and was the first Anglican Church in the area.
- (2) The wall framing has corner and intermediate posts 12" x 12" and 12" x 8" respectively.
- (3) There are diagonal braces on both the end and side walls.
- (4) One of the main features of the building is the roof framing. The king post roof truss used here was the 19th century modern form of truss.
- (5) The king post truss relies upon the principle rafters of the roof acting as a simple arch to support the king post. The head of the post is trapped by the principal rafter. Struts or braces prop the principles and carry the load from the purlins to the foot of the post. Therefore the king post is loaded at the foot and supported at the head.
- (6) The usual joint between the post and bottom chord was a strap iron clamp fitted around the chord with the end bolted to the bottom of the king post. This strap was omitted here and replaced by a two-pin mortise and tenson joint.
- (7) In addition to the roof load, the king post also carried part of the ceiling load, since the ceiling joists were originally formed into the beam.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Haldimand before the twenty-fourth day of June, 1983.
