

NOTICE OF INTENTION TO REPEAL BY-LAW NO 3-82
which By-law designated the Pickering Beach
Road Schoolhouse as a Heritage Property.

TAKE NOTICE that the Council of the Corporation of the Town of Ajax intends to repeal By-law No. 3-82 dated January 11, 1982, which By-law designated the property, including lands and buildings, at Concession B.F. Range III, Part Lot 6, (The Pickering Beach Road Schoolhouse), as a property of architectural and/or historical value or interest, under Part IV of The Ontario Heritage Act, Chapter 337, R.S.O. 1980.

(a) Municipal Address: Concession B.F. Range III, Part Lot 6, in the
Town of Ajax, Regional Municipality of Durham.

(b) Reason for repeal of By-law:
The Town of Ajax, through its "Pickering Beach Road Schoolhouse Committee" has been unable to raise sufficient funds to repair this building and due to the high costs of restoration has authorized the demolition of same, subject to the Ontario Heritage legislation.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Town of Ajax notice of his or her objection to the proposed repeal of By-law No. 3-82 together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Ajax shall refer the matter to the Conservation Review Board for a hearing.

THE LAST DAY FOR FILING OBJECTIONS WILL BE MARCH 19, 1985.
