

No. 110-81. A BY-LAW

*To repeal By-law No. 423-79 respecting the designation  
of the property at No. 73 Gormley Avenue.*

(Passed February 12, 1981.)

Whereas the owner of No. 73 Gormley Avenue, has applied pursuant to subsection 1 of section 34 of The Ontario Heritage Act, 1974, to the Council of the Corporation of the City of Toronto for its consent to the removal of the building from No. 73 Gormley Avenue;

And Whereas the period of 180 days under clause (b) of subsection 2 of section 34 of The Ontario Heritage Act, 1974 has expired and the removal of the building located at No. 73 Gormley Avenue has been completed.

Therefore the Council of the Corporation of the City of Toronto enacts as follows:

1. By-law No. 423-79, being "A By-law To designate the Property at No. 73 Gormley Avenue, of historic interest", is hereby repealed.
2. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon The Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Toronto.
3. The City Clerk is hereby authorized to delete the reference to the aforesaid property from the register referred to in subsection 1 of section 27 of The Ontario Heritage Act, 1974.
4. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
