

CITY OF TORONTO

BY-LAW No. 871-2003

To designate the property at 55 King Street West (Toronto-Dominion Centre) as being of cultural heritage value or interest.

WHEREAS the Council of the City of Toronto has caused to be served upon the owners of the property at 55 King Street West (Toronto-Dominion Centre) and upon the Ontario Heritage Foundation, notice of intention to designate the property and has caused the notice to be published in a newspaper having a general circulation in the municipality, as required by the *Ontario Heritage Act*; and

WHEREAS no notice of objection to the proposed designation was served upon the City Clerk; and

WHEREAS the reasons for designation are set out in Schedule "A" to this by-law;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The property at 55 King Street West, more particularly described in Schedule "B" and shown on Schedule "C" attached to this by-law, is designated as being of cultural heritage value or interest under Part IV of the *Ontario Heritage Act*.
2. The City Solicitor is authorized to cause a copy of this by-law to be registered against the property described in Schedule "B" to this by-law in the proper Land Registry Office.
3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owners of the property at 55 King Street West and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Toronto as required by the *Ontario Heritage Act*.

SCHEDULE "A"

The property at 55 King Street West is recommended for designation for its cultural heritage value or interest. The renowned architect, Ludwig Mies van der Rohe designed the complex, with the Toronto architectural firms of John B. Parkin Associates and Bregman and Hamann as the associate architects. Located on a granite-clad plaza at the southwest corner of King Street West and Bay Street, the core elements of the Toronto-Dominion Centre are the 56-storey Toronto-Dominion Bank Tower (1967), the single-storey Banking Pavilion (1968) and 46-storey Royal Trust Tower (1969).

The Toronto-Dominion Centre is an outstanding example of the International Style of architecture. The heritage/architectural attributes are found on the exterior of the Toronto-Dominion Bank Tower, the Banking Pavilion and the Royal Trust Tower, and on the interior of the Toronto-Dominion Bank Tower and the Banking Pavilion. The architectural features of note on the exterior of the three buildings are the concrete foundations, the load-bearing black-painted steel frames, the bronze-tinted glass curtain walls with mullions and a grid of exposed and painted steel I-beams, the revolving doors at the bases and, on the towers, the pilotis. The interior finishes (granite, marble, travertine, and oak) and custom-built fittings in the Banking Pavilion, in the lobbies of the Toronto-Dominion Bank Tower and the Royal Trust Tower, are significant interior heritage features.


