

No. 496-81. A BY-LAW

*To designate the Property at No. 75 Simcoe Street
of architectural value and of historic interest.*

(Passed August 10, 1981.)

WHEREAS The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest; and

WHEREAS the Council of The Corporation of the City of Toronto has caused to be served upon the owners of the lands and premises known as No. 75 Simcoe Street and upon the Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedule 'B' hereto; and

WHEREAS no notice of objection to the said proposed designation has been served upon the clerk of the municipality;

THEREFORE, the Council of The Corporation of the City of Toronto enacts as follows:

1. There is designated as being of architectural and historic value or interest the real property more particularly described in Schedule 'A' hereto, known as No. 75 Simcoe Street.
2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule 'A' hereto in the proper land registry office.
3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Toronto.

SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Toronto, in the Municipality of Metropolitan Toronto and Province of Ontario, being composed of part of Lot 11 on the south side of King Street, now King Street West, according to the Town of York Plan, the said parcel of land being designated as PART 1 on a plan of survey deposited in the Land Registry Office for the Registry Division of Toronto (No. 63) as 63R-2198.

The easterly limit of Simcoe Street, southerly limit of King Street West and westerly limit of Emily Street confirmed under The Boundaries Act by Plan BA-1325 on 26 July 1978 as Instrument CT308070.

SCHEDULE "B"

Reasons for the designation of the Property at No. 75 Simcoe Street.

St. Andrew's Presbyterian Church at No. 75 Simcoe Street is designated on architectural and historic grounds. Built in 1875 to replace the original building at Church and Adelaide Streets, this church is an outstanding example of the work of Architect William George Storm. The picturesque, massive and richly detailed stone exterior with towers, spires and bartizans, is complemented by the interior serenity of the decorative chancel, the stained glass and the sweeping balcony in the nave. The congregation, founded in 1830 in connection with the Church of Scotland, has historic links with the development of social work in the City of Toronto.
