Take notice that the Council of the Corporation of
the City of Toronto on the 9th, 10th and 12th days of November,
1976, pursuant to the Notice of Hearing dated November 4th, 1976,
having considered the application for Consent to Demolish and
Remove the buildings and structures located on the property known
municipally as No.76 Dundas Street East, and after giving con-
sideration to the matter, decided:

- (A) TO REFUSE THE APPLICATION TO DEMOLISH UNDER
SECTION 34 OF THE ONTARIO HERITAGE ACT AND
PROHIBIT ANY WORK TO DEMOLISH OR REMOVE ANY
BUILDING OR STRUCTURE ON THE PROPERTY KNOWN
MUNICIPALLY AS NO.76 DUNDAS STREET EAST FOR
A PERIOD OF ONE HUNDRED AND EIGHTY (180) DAYS
FROM THE 12TH DAY OF NOVEMBER, 1976; AND

(B) TO APPOINT A COMMITTEE COMPOSED OF

ALDERMAN DAVID SMITH

ALDERMAN DAN HEAP

ALDERMAN ALLAN SPARROW


