**The Corporation of the Town of New Tecumseth In the matter of the Ontario Heritage Act, 1990  
R.S.O. Chapter O.18**

**34 Main Street West, Town of New Tecumseth (Beeton), Province of Ontario**

Take notice that the Council of the Corporation of the Town of New Tecumseth intends to designate, under Part IV, Section 29 of the Ontario Heritage Act the façade along with the East and West brick walls of the building described as Concession 8, Lot 10, municipally known as 34 Main Street West, in the Town of New Tecumseth (Beeton), in the County of Simcoe, in the Province of Ontario.

**Reasons for Proposed Designation:**

The Beeton Town Hall is a three-storey commercial building, located on the north side of Main Street in the former village of Beeton, now included within the amalgamated Town of New Tecumseth. The Town Hall was designed by architect M.B. Aylesworth and construction was tendered to Arthur Goldsmith in 1894 for the price of \$3,500. Bricks were supplied by the Bemrose Brick Yard which was located north of Beeton. The structure was officially opened on February 15<sup>th</sup> 1895.

From the beginning the building was the centre of the community. It housed Council chambers, an auditorium, the fire hall and a jail. A large room in the back was used for a weekly farmer's market. The Town Hall was closed in 1946 and purchased by the Cooper-Weeks company (later Cooper Canada Ltd.). York-Simcoe Printing occupied the building for decades afterwards.

The intent of the proposed designation is to preserve the façade along with the East and West brick walls of the Beeton Town Hall building. In addition to the spectacular architectural features, this building has stood out as the crown jewel of the downtown core since 1895. Both the Beeton branch of the New Tecumseth Public Library and the future design plan for a new community centre/arena have been heavily influenced by the façade of the Town Hall building.

The designation applies to the façade of the building along with the East and West exterior brick walls. Specific architectural details include: a three-storey Italianate Style building, elaborate ornamentation of cornices, windows and doorways and the Rose window.
