

**NOTICE OF INTENTION TO DESIGNATE**

TAKE NOTICE that the Council of the Town of Essex intends to designate the property, including land and buildings, at the following municipal address as a property of architectural and historic value or interest pursuant to the provisions of the Ontario Heritage Act, 1990, and amendments thereto:

Any person may, within thirty (30) days of the publication of this notice, serve upon the Clerk a notice of objection setting out the reason for the objection and all relevant facts. If no notice of objection is served within the thirty (30) day period, the Council of the Town of Essex shall pass a By-Law designating the property.
