


AND WHEREAS the legal description of the property was incorrectly described in By-law Number (2003)-17098;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF GUELPH ENACTS AS FOLLOWS:

1. The recital of By-law Number (2003)-17098 is hereby amended by deleting the words "legally described as Pt Lot 60, 67, 72 to Pt Lot 75, Lot 62, Lot 69, Lot 70 and Lot 71 of Registered Plan 113", and substituting the following words: "legally described as Lot 62, Plan 113; Lots 69, 70, 71, 72, 73, 74 and 75, Plan 113; Part Lots 60 and 67, Plan 113, designated as Parts 1 and 2, Reference Plan 61R-1626".
2. By-law Number (2003)-17098 is hereby further amended by deleting the existing schedule "A" and substituting the attached Schedule "A".
