Dear Madam:

Further to our previous conversations and correspondence concerning the designated property grants segment of the building rehabilitation and improvement campaign.

Kindly find enclosed herewith a copy By-Law No. 36-1984, a by-law passed, designating the gates at Vanastra Park to be of a significant architectural and historical value to the Township of Tuckersmith. We would like to advise that at Vanastra Park, the gates served as one of the first entrances to the R.C.A.F. Base, the first radar training school for the government of Canada after the war and had a significant influence on the development of the Township of Tuckersmith and the surrounding area. We would like to advise further that the base was closed in 1969 and the gates remained one of the remaining features of the former base. We are also enclosing herewith a copy of the ad that will appear in the Clinton News Record, a paper having general circulation in the area for 3 consecutive weeks. I hope that this action of Council meets with your approval.

## THE CORPORATION OF THE TOWNSHIP OF TUCKERSMITH BY-LAW NO. 36-1984

Being a by-law to designate the Gates and Posts on Lane E, in Vanastra Park, in the Township of Tuckersmith, of architectrual and historical value.

WHEREAS the Ontario Heritage Act, R.S.O. 1980, Chapter 337,
Part IV authorized the Council of a Municipality to enact by-laws
to designate real property including all the building and structures
thereon to be of historic or architectural value and interest and;

whereas the Council of the Township of Tuckersmith has caused to be served upon the owner of the lands and premises known as the Lot 31, Lot 32 and Lane E, Plan 133, Vanastra Park, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the Municipality once for each of three consecutive weeks, and;

WHEREAS the reason for designation is that the Gates served as the main entrance to the Radar Base, first one constructed in Canada in the 1940's and had sufficient influence on the development of the Township of Tuckersmith and;

WHEREAS no notice of objection to the said proposed designation has been served upon the Clerk of the Municipality.

THEREFORE the Corporation of the Township of Tuckersmith ENACTS
AS FOLLOWS:

- 1: The lands designated as being of architectural and historical value that certain parcel or tract of land and premises situated and lying and being in the Township of Tuckersmith, in the County of Huron, and the Province of Ontario, and Posts and Gates constructed on Lot 31, 32 and Lane E, Plan 133, Vanastra Park, for the Township of Tuckersmith.
- 2. That the Clerk be hereby authorized to cause a copy of thie by-law to be registered against a certain parcel or tract of land and premises situated and lying and being in the Township of Tuckersmith, in the County of Huron, and the Province of Ontario, and being composed of Lot 31, 32 and Lane E, Plan 133, Vanastra Park, in the Township of Tuckersmith.

3. That the Clerk is hereby authorized to cause a copy of this by-law to be served upon the owners of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having a general circulation in the Township of Tuckersmith.
