**TOWNSHIP OF CENTRE WELLINGTON**

**BY-LAW NO. 2006-22**

Being a By-law to designate 270 Bridge Street  
in the former Town of Fergus,  
to be of cultural heritage value or interest

**WHEREAS** on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

**AND WHEREAS** the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:**

1. The lands and premises described as 270 Bridge Street, Plan 55, Part Lot A, N/S Union Street West, (Formerly Town of Fergus), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
2. The reasons for the designation are as follows:

**Cultural Heritage Value or Interest:**

This single detached dwelling, with a 1 ½ storey centre gable and rectangular plan long façade, is constructed of cut/broken course limestone with cut quoins. The centre façade main entrance is on Union Street with a basement entrance on Bridge Street. The house is estimated to be built in 1850.


**Heritage Attributes to be protected:**

The exterior limestone walls including quoins.

3. This By-law shall be registered against the title of the lands described 270 Bridge Street, Plan 55, Part Lot A, N/S Union Street West, (Formerly Town of Fergus), now in Township of Centre Wellington
4. This By-law shall come into force and take effect upon its final passing.


