NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of the Corporation of the Township of Centre Wellington intends to designate the properties at the following municipal addresses as properties of cultural heritage value or interest under Part IV of the *Ontario Heritage Act*, R.S.O. 1990, as amended, (Ch.O.18, Sec. 29)

FERGUS

235 St. David St. South (Also known as the Beatty Coach House - 220 Bridge Street)

It is believed to have been built at the same time as the house (built in 1912 for W.G. Beatty and his wife) as all photos from this time include the house, the "coach house", the wishing well, and the rock garden. What is now living quarters on Bridge Street was first the stable, then the garage.

What is to be Protected by Designation

- The original window openings on both sides of the "coach house"
- The original rubble stone construction
- The original rock garden running along Bridge Street
- The "wishing well"
- The view-shed from the "coach house" to the main house; no additional building to occur between these two structure

SALEM

467 Geddes Street

This building is a fine old stone home constructed in 1856 by Sem Wissler, one of the first settlers in the area and a prominent member of Salem society in the 1800's. It is typical and closely resembles its original construction.

What is to be Protected by Designation

- The stone exterior, including quoins and voussoirs over windows and lintel over the front door
 - Original window and door openings
 - Existing mass including roofline and shape
