BY-LAW 2010-088

Being a by-law to repeal By-law 2006-072 as it affects
the severed lands described as Parts 6, 7, 8 and 9,
Reference Plan 61R11258, Fergus, Township of Centre
Wellington.

WHEREAS By-law 2006-072 is a By-law to designate 680 Tower Street South (the "Lands") to be
of cultural heritage value or interest;


AND WHEREAS the Lands have now been severed creating two parcels of land;

AND WHEREAS the Municipal Heritage Committee has agreed that the heritage designation
should only apply to the parcel of land described in Schedule "A" and By-law 2006-072 be
repealed on the parcel of land described in Schedule "B";

**THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON
HEREBY ENACTS AS FOLLOWS:**

1. By-law 2006-072 is hereby repealed on the lands described in Schedule "B" attached
hereto.
2. This By-law shall be registered against the title of the lands described in Schedule "B".
3. This by-law shall come into force and take effect upon its finally passing.
