CORPORATION OF THE TOWNSHIP OF HALDIMAND

BY-LAW NUMBER 85-15

BEING A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS ACADEMY HILL CEMETERY
AS BEING OF ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST

WHEREAS section 29 of the Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Township of Haldimand has caused to be served on the owners of the lands and premises known as ACADEMY HILL CEMETERY

at Lot 22, Conc. 2, Haldimand Township, County of Nurthumberland

and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality; and

WHEREAS the Council has considered the report of the Appointed Local Architectural Conservation Advisory Committee (LACAC)

THEREFORE the Council of the Corporation of the Township of Haldimand enacts as follows:

1) There is designated as being of architectural and/or historical value or interest the real property known as

ACADEMY HILL CEMETERY

at Lot 22, Conc. 2, Haldimand Township, County of Northumberland

more particularly described in schedule A hereto.

- 2) The municipal solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Scedule A hereto in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

Lot 22, Conc, 2, Haldimand Township, County of Northumberland

HISTORICAL SIGNIFICANCE:

REEVE

The Academy Hill Cemetery is an abandonned Pioneer Cemetery of Historical Significance. The first burial appears to be a "Susanna Merriam" dated on Feb. 14, 1815. The last burial appears to have been a "Lydia Lapp", dated Oct. 15, 1902.

The Pioneer family names are—; SHAW, MOORE, MERRIAM, RICHARDSON, MASSEY, MASTERS, WINTER, BOLAND, WAIT, SARGENT, NOBLE, NOBLES, BRADLEY, IRISH, ALLEN, LAPP, CROUTER, MERREL, TUCKER, FISH, TAYLOR, EDDY, STEWART.
