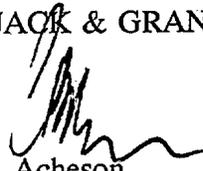

THE CORPORATION OF THE TOWN OF FERGUS

BY-LAW NUMBER 3179

*Being a By-law to designate 585
Garafraxa Street East, to be of
historic or architectural value or
interest.*

WHEREAS on the advice of the Local Architectural Advisory Committee, Council has been advised to designate the lands attached hereto to be of historic or architectural value or interest pursuant to the provisions of the Ontario Heritage Act, R.S.O. 1990, c. O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (4) have been complied with and no notice of objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF FERGUS HEREBY ENACTS AS FOLLOWS:

1. The lands and premises described in Schedule "A" attached hereto are hereby designated to be lands and buildings of historic or architectural value or interest.

2. The reasons for the designations are as follows:

In 1845 the land on which this house was built was part of Lot 8 Concession 1, Township of West Garafraxa, which consisted of 160 acres granted by the Crown to Adam Ferguson and others in trust.

In 1860 the easterly portion of the lot, 100 acres, was sold; and in 1864 the westerly portion was sold to Robert Lingwood.

Following a sale of 1.13 acres by Robert Lingwood to his brother William in 1867, the remainder of Robert Lingwood's holdings was sold to Henry Webster in 1873 who occupied the property until his death in 1911. The property was subsequently acquired by James Caldwell and remained in their family until the 1940's or 50's.


The original house is a one and a half storey, three bay structure built of limestone rubble. It measures approximately 29 feet wide by 23 feet deep. An addition in brick was made to the rear (north). Because the peak and eaves lines are continuous, and a dormer duplicates that in the original building, the total structure presents an integrated appearance.


Although it is not possible to determine the exact date that the house was built, it was most likely built by Robert Lingwood between 1864 and 1873.

3. This By-law shall be registered against the title of the lands described in Schedule "A".


4. This By-law shall come into force and effect upon its final passing.




