





TAKE NOTICE that the Council of the Corporation of the City of Sault Ste. Marie intends to designate the property, including land and buildings, known municipally as 160 Spring Street, as property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

REASONS FOR PROPOSED DESIGNATION

160 SPRING STREET - CENTRAL UNITED CHURCH

Central United Church, designed by architect Harry Simpson of Toronto and built in stages between 1900 and 1911, is a powerfully modelled building constructed of local sandstone.

Although difficult to slot into any particular architectural style, its massive appearance nevertheless reflects the original request to the architect to create a church with a style "indicative of Methodism".

NOTICE of objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the City of Sault Ste. Marie before the 9th day of September 1985.
