
Dear Sir:

NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of the Corporation of the Town
of Goderich, on the 13th day of July 1981,
decided to designate the lands and buildings, known
municipally as Garvey House as a property of
architectural and/or historical significance under The
Ontario Heritage Act, 1974, S.O. Chapter 122.

REASON FOR PROPOSED DESIGNATION

"The Garvey House." The Garvey House has architectural and historical
merit that makes it deserving of historical designation. Built c 1850,
it is one of the older properties being considered in this notice. It
is also one of the older examples of the Gothic/Picturesque influences
in the area. The house is constructed of soft red brick bearing walls
which have been covered with concrete 'formed block' on the exterior.
A sharply pitched center gable is ornamented with detailed bargeboard.
The original windows of the house are four over four with peculiar
measurements.

Notice of objection to the designation may be served on the
Town Clerk within thirty days of the 15th day of July
1981.
