

Take notice that the Council of the Corporation of the Town of
Goderich, on the 20th day of September, 1982 decided to designate
the lands and buildings, known municipally as "The Warnock House"
as a property of architectural and/or historical significance
under The Ontario Heritage Act, Chapter 337, R.S.O. 1980, Part 4.


REASON FOR PROPOSED DESIGNATION

"The Warnock House" has been recommended for designation for
architectural reasons. Although John Brackenridge built the
house around 1885, it was occupied by the Warnock family for
over a half a century. The house is an excellent example of
Italianate architecture uncommon to Goderich. This large,
brick structure is one of the earlier residences to locate in
the east end of town on Albert Street. It has since retained
a dignified manner set apart from the neighbouring houses by its
unique style and massive lot. On the east end of the lot stands
the original coach house.

Notice of objection to the designation may be served on the
Town Clerk within thirty days (30) of the 29th day of September,
1982.
