

Take notice that the Council of The Corporation of the Town of
Goderich, on the 20th day of September, 1982 decided to
designate the lands and buildings, known municipally as "The
Holt House" as a property of architectural and/or historical
significance under The Ontario Heritage Act, Chapter 337, R.S.O.
1980, Part 4.


REASON FOR PROPOSED DESIGNATION

"The Holt House", 138 North Street, has been recommended for
designation for historical and architectural reasons. The
house, built around 1889, was the long time residence of Judge
Philip Holt. In 1902, Holt became Junior Judge of Huron and
served frequently as a warden of St. George's Anglican Church.
The house is a departure from earlier simple styles with a large,
low hipped roof and side bay window. The stained glass details
and decorative gingerbread enhance the aesthetic qualities of
the house and property.

Notice of objection to the designation may be served on the
Town Clerk within thirty days (30) of the 29th day of
September, 1982.
