A BY-LAW

Number 4097-82

TO DESIGNATE property in the Borough of York, municipally known as Number 2371 Weston Road, to be of historic and architectural value or interest.

WHEREAS Council has been advised by The Local Architectural Conservation Advisory Committee of the Borough of York that the property at Number 2371 Weston Road, in the Borough of York, has architectural and historical value and interest and should be designated pursuant to Section 29 of The Ontario Heritage Act, Statutes of Ontario, 1974;

AND WHEREAS Council is satisfied that the building located on the premises has historic and architectural value or interest, having been built in 1841 and being the oldest existing building in that portion of the Borough of York which was formerly the Town of Weston;



NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE BOROUGH OF YORK ENACTS AS FOLLOWS:

- 1 -

THAT the property known municipally as Number 2371 Weston Road, in the Borough of York, and more particularly described in Schedule "A" attached hereto, be and the same is hereby designated as a property of historic and architectural value or interest.

READ A FIRST AND SECOND TIME this 23rd day of November, A.D. 1981.

READ A THIRD TIME AND FINALLY PASSED this 1st day of March, A.D. 1982.
