Take notice that the Council of the Corporation of  
the City of Toronto, on the 18th day of August, 1976, having  
considered the application for Consent to demolish the College  
Street Wing of the Eaton's College Street Building, on the property  
known municipally as Nos.412-448 Yonge Street, and after giving  
consideration to the matter, decided:

TO GRANT THE APPLICATION TO DEMOLISH THE COLLEGE  
STREET WING OF THE EATON'S COLLEGE STREET BUILDING  
ON THE PROPERTY KNOWN MUNICIPALLY AS NOS.412-448  
YONGE STREET; SUBJECT TO THE APPLICANT AND THE  
CITY ENTERING INTO AN APPROPRIATE LEGAL AGREEMENT  
TO SECURE THE PROVISION OF A TEMPORARY PARK ALONG  
COLLEGE STREET AND PUBLIC ACCESS THERETO;  
AND SUBJECT FURTHER TO

(A) THE APPLICANT UNDERTAKING NOT TO OBJECT TO THE  
CLOSING OF HAYTER STREET.

(B) THE APPLICANT UNDERTAKING NOT TO OBJECT TO THE  
RELOCATION OF ALL VEHICULAR ACCESS FROM HAYTER STREET  
IF SUCH STREET IS TO BE CLOSED.

(C) THE APPLICANT UNDERTAKING NOT TO OBJECT TO THE  
NARROWING OF YONGE STREET AT THIS LOCATION.
