

TAKE NOTICE that the Council of The Corporation of The Town of Milton intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and historical value or interest under Part IV of The Ontario Heritage Act, 1980, R.S.O. Chapter 337.

Municipal Address: 5576 Highway 25, Milton, Ontario

Reasons for Proposed Designation:

This building, based on the Georgian Style of Architecture, is a large, two storey square plan house with double thick brick walls made of hand pressed red brick; its design was very popular with traditional homes in the mid-19th Century.

The Crown registered this property under its name in 1827. Levi Wilson became the Owner of the property in 1850. It should be noted that Mr. Wilson was the first Sheriff of the District of Halton and may have kept prisoners in the basement of the house.

Notice of Objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Milton before the 20th day of July, 1984.
