**Re: Amendment to Legal Description of Designated Property  
895 Bronte Street, South, Milton  
(Formerly 6607 First Line)**

895 Bronte Street was designated as being of cultural value or interest by By-law No. 090-2009 in July, 2009. 895 Bronte Street is now part of a residential subdivision and is located on a parcel of land that was conveyed by the developer to the Town as a park use. The farmhouse and barn located on the property will be incorporated into the park use. The legal description of By-law No. 090-2009 was required to be amended to include only the parcel of land where the farmhouse and barn are located.

No notices of objection were received to the proposed amendment, and the Town's Heritage Committee approved the amendment, resulting in the by-law being passed by Milton Council on October 12, 2010. A copy of the by-law is enclosed.

BY-LAW NO. 128 - 2010

BEING A BY-LAW TO AMEND BY-LAW NO. 090-2009, A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS THE EXTERIOR AND INTERIOR OF THE HOUSE AT PART LOT 9, CONCESSION 2 NS, AS BEING OF CULTURAL HERITAGE VALUE OR INTEREST. (895 BRONTE STREET)

**WHEREAS** Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter c.O. 18, as amended, authorizes the Council of a municipality to enact by-law to designate real property including all buildings and structures thereon, to be of cultural heritage value or interest;

**AND WHEREAS** the Council of the Corporation of the Town of Milton approved By-law No. 090-2009 on July 20, 2009 which designated 895 Bronte Street as being of cultural heritage value or interest;

**AND WHEREAS** the Council of the Corporation of the Town of Milton is desirous of amending the legal description found in By-law No. 090-2009 to only include Part 1 on Plan 20R-18720;

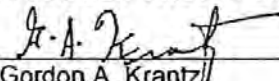
**NOW THEREFORE** the Council of the Corporation of the Town of Milton hereby enacts as follows:

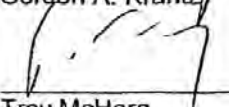
1. **THAT** the legal description as set out in Schedule "A" to By-law No. 090-2009 be amended to read:

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Milton, Regional Municipality of Halton, and being composed of Part of Lot 9, Concession 2 NS, designated as Part 1 on Plan 20R-18720.

2. **THAT** all other provisions of By-law No. 090-2009 remain in force and effect.
3. **THAT** if no appeal is filed pursuant to the *Ontario Heritage Act*, R.S.O. 1990, c. O.18, as amended, this by-law shall come into force on the day of its passing and shall be registered in the Land Registry Office for Halton No. 20.

**READ a FIRST, SECOND and THIRD TIME and FINALLY PASSED** this 12th day of October, 2010.

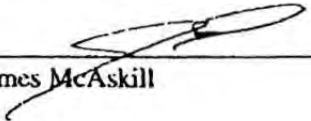
