Re: Amendment to By-law No. 44-84 Designating 5576 regional Road 25 (Formerly Highway 25) as Being of Architectural and Historical Value or Interest

By-law No. 44-84 was passed by the Council of the Corporation of the Town of Milton on July 23, 1984. The owner of 5576 Regional Road 25 has dedicated Part 4, Plan 20R-18874 to the Regional Municipality of Halton for road widening purposes. As such, the legal description of By-law 44-84 has been amended to exclude Part 4, Plan 20R-18874 from the heritage designation.

The Town of Milton notified the affected property owner that it proposed to amend the legal description of By-law No. 44-84 to exclude Part 4, Plan 20R-18874 from the heritage designation. No notice of objection was received to the proposed amendment, resulting in By-law No. 090-2011 being passed by Milton Council.

## THE CORPORATION OF THE TOWN OF MILTON

## BY-LAW NO. 090-2011

BEING A BY-LAW TO AMEND BY-LAW NO. 44-84, AS AMENDED, A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 5576 HIGHWAY 25 AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST

WHEREAS Part IV of The Ontario Heritage Act, R.S.O. 1990, Chapter 0. 18, as amended, authorizes the Council of a municipality to enact a by-law to designate real property, including all buildings and structures thereon, to be of cultural heritage value or interest:

AND WHEREAS By-law No. 44-84 was approved by Council on July 23, 1984, which by-law designated 5576 Highway 25 as being of architectural and historical value or interest:

**AND WHEREAS** the legal description of By-law No. 44-84 was amended by By-law No. 76-90 to exclude Part 13 Plan 20R-9465 as being of architectural and historical value or interest:

AND WHEREAS the owner of 5576 Regional Road 25 (formerly Highway 25) is dedicating certain lands to the Regional Municipality of Halton;

AND WHEREAS notice was provided to the affected property owner to inform her that By-law No. 44-84 is being amended;

AND WHEREAS since no objections have been received regarding the amendment to By-law No 44-84, Council is desirous of amending the legal description of By-law No. 44-84 to exclude the lands being dedicated to the Regional Municipality of Halton as being of architectural and historical value or interest.

**NOW THEREFORE** the Council of the Corporation of the Town of Milton hereby enacts as follows:

- 1. THAT the legal description as set out in Schedule "A" to By-law No. 44-84 be further amended to exclude Part 4, Plan 20R-18874 as being of architectural and historical value or interest.
- 2. THAT all other provisions of By-law No. 44-84 remain in force and effect.

3. THAT this By-law shall come into force and effect on the day it is passed.

READ a FIRST, SECOND and THIRD TIME and FINALLY PASSED this 26th day of September, 2011.
