## CORPORATION OF THE TOWN OF RIDGETOWN

## BY-LAW 83-- 37

A By-law to designate property known municipally as the Presbyterian Church, 59 Main Street East, as being of architectural and historical value or interest.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon to be of architectural or historic value or interest;

AND WHEREAS the Council of the Corporation of the Town of Ridgetown has caused to be served on the owners of the lands and premises known as the Presbyterian Church at 59 Main Street East, Ridgetown, Ontario, and upon the The Ontario Heritage Foundation, Notice of Intention to so designate the aforesaid real property and has caused such Notice of Intention to be published in the same newspaper having general ciruculation in the municipality once for each of three consecutive weeks;

AND WHEREAS no Notice of Objection of the proposed designation has been served upon the Clerk of the municipality.

THEREFORE the Council of the Corporation of the Town of Ridgetown enacts as follows:-

 There is designated as being of architectural and historical value or interest the real property known as the Presbyterian Church at 59 Main Street East, Ridgetown, Ontario, more particularly described in Schedule "A" hereto.

2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The Clerk is hereby authorized to cause a copy of this
By-law to be served on the Owner of the aforesaid property and
on The Ontario Heritage Foundation and to cause notice of the
passing of this By-law to be published in the same newspaper
having general circulation in the municipality once for each of
