

DESIGNATION OF LANDS AND BUILDINGS
TO BE OF HISTORICAL AND
ARCHITECTURAL VALUE AND
INTEREST IN THE TOWN OF AMHERSTBURG

TAKE NOTICE THAT the Council of the Corporation of the Town of Amherstburg intends to pass a by-law at its meeting of September 26, 1977 to designate certain lands and buildings located in the Town of Amherstburg to be of historical and architectural value and interest.

The said lands being:

1. THE LIGHTHOUSE CHAPEL formerly known as CATHOLIC PARISH HALL, located at 266 King Street, being lots 30 and 31, Registered Plan 1, in the Town of Amherstburg. This building of random limestone is architecturally significant as it is an example of early school house in Ontario.
2. FIRST BAPTIST CHURCH, located at 232 George Street, forming Lot 27, Registered Plan 1, in the Town of Amherstburg. Historically, the building is one of the oldest Baptist Churches in Ontario.
3. THE BULLOCK'S TAVERN located at 267 Dalhousie Street, being West Part of Lot 9, Registered Plan 1 in the Town of Amherstburg. This old commercial building is of rough cast stone with plaster coating. It is one of the oldest commercial blocks in Amherstburg.
4. THE ROBERT TRIOLET RESIDENCE located at 235 King Street, forming part of Lot 15, Registered Plan 1 in the Town of Amherstburg. This historic house, built before 1830 is a very early example of solid log construction.
5. THE MELVIN (MAC) SIMPSON RESIDENCE located at 281 King Street, being Lot 6, Registered Plan 1 in the Town of Amherstburg. This is the only known example in the area with a log and brick construction and with the original clapboard siding.
6. THE FRANK KEHL RESIDENCE located at 284 Ramsay Street, forming Lot 21, Registered Plan 1 in the Town of Amherstburg. The Building is one of the two examples of early Georgian brick architecture in Amherstburg.
7. THE RALPH JIMMERFIELD RESIDENCE located at 217 Gore Street, being Lot 8, Registered Plan 1 in the Town of Amherstburg. This is the only building in the area with a salt box construction and exhibiting the original casement window at the upper level.
8. CHURCH OF GOD IN CHRIST located at 246 King Street, being Lot 27, Registered Plan 1 in the Town of Amherstburg. The building, built in the late 19th Century, was used as a school house, with the characteristics of the early one-room school in rural Ontario.
9. ADRIANO TONON RESIDENCE located at 187 Murray Street, being part of Lot 16, Registered Plan 1 in the Town of Amherstburg. This is one of the early settlers log houses with simple pattern built around 1860s in Ontario.
10. THE GIBB HOUSE (HERITAGE HOUSE) located at 193 Gore Street, forming part of Lot 9 and 10, Registered Plan 1 on the south side of Gore Street in the Town of Amherstburg. This is the only example that exhibits the interesting local feature of "Block" wood siding in imitation of a cut stone appearance.

And further, that any person interested may, within thirty (30) days after the date of the 1st publication of this Notice, send by registered mail or deliver to the Clerk of the Town of Amherstburg, Town Offices, 271 Sandwich Street, notice of his objection to a proposed designation, together with a statement of the grounds of such objection.

And further, that where notice of objection has been received, the Council of the Corporation of the Town of Amherstburg shall refer the matter to the Review Board for a hearing and report.
