Pursuant to Section 32(2)(b)(i) of the Ontario Heritage Act, I am enclosing a copy of By-law Number 1987-24, being a by-law to repeal By-law Number 1986-116, which designated the St. James' Anglican Church Rectory as a property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 198, Chapter 337.

The designating by-law was never registered as the owners applied for the repeal of the designation immediately after the by-law was passed.



BY-LAW NUMBER 1987-24 OF THE CITY OF ORILLIA

A BY-LAW TO REPEAL BY-LAW NUMBER 1986-116, A BY-LAW TO DESIGNATE THE ST. JAMES ANGLICAN CHURCH RECTORY AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST


WHEREAS Council, with the consent of the owner, passed By-law Number 1986-116, being a by-law to designate the St. James Anglican Church Rectory as being of architectural and historical value or interest, pursuant to the Ontario Heritage Act, R.S.O. 1980, Chapter 337;

AND WHEREAS St. James' Anglican Church, being the owners of the property, have now requested the repeal of the designating by-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF ORILLIA HEREBY ENACTS AS FOLLOWS:

1. THAT By-law Number 1986-116 be and it is hereby repealed.
