

NOTICE OF DECISION

TAKE NOTICE that, at its meeting held on November 8, 1994, the
Council of The Corporation of the City of Hamilton decided to refuse an application for a
permit to demolish 68 King Street East, Hamilton for a period of 180 days from November
8, 1994 pursuant to the provisions of Section 34 of the Ontario Heritage Act.

68 King Street East, Hamilton, (briefly described as Part 2 on Reference
Plan 62R-7339), was designated by By-law No. 84-249 as an historical site pursuant to the
Ontario Heritage Act.
