**NOTICE OF INTENTION TO AMEND A HERITAGE DESIGNATION
UNDER THE ONTARIO HERITAGE ACT, R.S.O. 1990, c. O.18**

TAKE NOTICE that the Council of the Corporation of the Town of Gravenhurst intends to amend By-law 83-05, being a By-law to designate the Albion Hotel under the Ontario Heritage Act, for lands located at 100 Muskoka Road North, in the Town of Gravenhurst, District Municipality of Muskoka, under Section 30.1 (1) of *The Ontario Heritage Act* (R.S.O. 1990, Ch. O. 18).

A By-law to amend the designation By-law is to be considered by Gravenhurst Town Council at its regular meeting to be held at **5:00 p.m. on Tuesday June 5, 2012.**

REASONS FOR DESIGNATION (from By-law 83-05): The Albion Hotel of Gravenhurst is one of the few remaining examples of the nineteenth Century Hotel architecture of the Gothic Revival period. The three storey red brick hotel, is the anchor building. It is situated at the main intersection of the Town, on the north east corner of Muskoka and Brock Streets. It has been an important part of life and heritage of Gravenhurst from the lumber and steam era to the present time. Revitalized through restoration, the Albion Hotel would greatly enhance Gravenhurst's town core, tying in significantly with the C.N. Station, the Norman Bethune House, the Opera House complex and the historic R.M.S. Segwun.

THE BY-LAW is being amended in order to remove the Covered Balcony from the list of Architectural Features in Schedule "A". The request has been made by the owner as a response to structural concerns.

Any person may send by registered mail or deliver to the Clerk of the Town of Gravenhurst notice of their objection to the proposed amendment together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Town of Gravenhurst will refer the matter to the Conservation Review Board for a hearing.
