**BY-LAW 2000-122**

**BEING A BY-LAW OF THE CORPORATION OF THE CITY OF SUDBURY  
TO AMEND THE ARCHITECTURAL/HISTORIC DESIGNATION OF THE ART  
GALLERY OF SUDBURY, FORMERLY LAURENTIAN UNIVERSITY MUSEUM AND  
ARTS CENTRE (LUMAC) IN THE CITY OF SUDBURY IN THE REGIONAL  
MUNICIPALITY OF SUDBURY, TO PERMIT ALTERATIONS AND RENOVATIONS TO  
THE INTERIOR SPACE OF THE ART GALLERY OF SUDBURY**

WHEREAS by By-Law 83-204, "BEING A BY-LAW OF THE CORPORATION OF THE CITY OF SUDBURY TO DESIGNATE LAURENTIAN MUSEUM AND ARTS CENTRE IN THE CITY OF SUDBURY IN THE REGIONAL MUNICIPALITY OF SUDBURY AS A PROPERTY OF ARCHITECTURAL AND HISTORICAL VALUE PURSUANT TO THE ONTARIO HERITAGE ACT", Council designated the whole of the real property known as Laurentian Museum and Arts Centre, now the Art Gallery of Sudbury, at 468 Ramsey Road in the City of Sudbury as being of architectural and historic value or interest;

AND WHEREAS the Board of Directors of the Art Gallery of Sudbury has applied to the Council of The Corporation of the City of Sudbury to amend the designation for the purpose of implementing interior renovations to the Art Gallery of Sudbury to achieve the following objectives:


- (a) life and safety issues;
- (b) accessibility requirements;
- (c) required upgrades to exhibition spaces for current and proposed exhibits;  
and,
- (d) routine maintenance and repair;


AND WHEREAS Section 33 of the Ontario Heritage Act provides that an owner of a designated property shall not alter the property or permit the alteration of the property where the alteration is likely to affect the reason for the designation, unless the owner applies to the Council and receives consent in writing to make such alteration.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF SUDBURY HEREBY ENACTS AS FOLLOWS:

1. THAT the application of Laurentian University and the Art Gallery of Sudbury, to implement interior renovations to the Art Gallery of Sudbury situate and forming part of the real property formerly known as the Laurentian University Museum and Art Centre, located at 468 Ramsey Road in the City of Sudbury in the Regional Municipality of Sudbury, be and is hereby approved.
2. THAT Section 1 of By-law 83-204, "BEING A BY-LAW OF THE CORPORATION OF THE CITY OF SUDBURY TO DESIGNATE LAURENTIAN MUSEUM AND ARTS CENTRE IN THE CITY OF SUDBURY IN THE REGIONAL MUNICIPALITY OF SUDBURY AS A PROPERTY OF ARCHITECTURAL AND HISTORICAL VALUE PURSUANT TO THE ONTARIO HERITAGE ACT", be and is hereby amended, by removing from its designation the interior space of the of the Art Gallery of Sudbury.
3. THAT a certified true copy of this by-law shall be registered against the real property affected by this designation.
4. THAT notice of Council's decision to permit the proposed renovations to the interior space of the of the Art Gallery of Sudbury shall:
  - (a) be given to the owner, Laurentian University, the Art Gallery of Sudbury and to the Ontario Heritage Foundation; and,
  - (b) be published in a newspaper having general circulation in the City of Sudbury, in the English and French languages.
5. THAT this by-law shall come into force and take effect immediately upon the final passing thereof.
