Notice of Passing of By-law

Take Notice that the Council of The Corporation of the Town of Vaughan has passed By-law Number 18-82 to designate the following property as being of historical and architectural value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337:

The "Old Presbyterian Church"
7788 Yonge Street, Thornhill, Ontario.

Reasons for the Proposed Designation

The Old Presbyterian Church (built ca. 1846 as the British Methodist Chapel) is one of the few remaining examples of the modest ecclesiastical architecture employed by Methodist congregations in the second quarter of the 19th century. Elements of the Greek Revival style are evident in the building's temple form and such architectural details as the pedimented gable in the front facade and the eared mouldings which trim each window. This church forms an integral part of what is left of the historic streetscape on the west side of Yonge Street, and with its neighbouring landmarks, serves to remind future generations of the architectural roots of Thornhill.

THE CORPORATION OF THE TOWN OF VAUGHAN

BY-LAW NUMBER 18-82

A By-law to designate the property known municipally as 7788 Yonge Street, Thornhill, as being of architectural value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and,

WHEREAS the Council of The Corporation of the Town of Vaughan has caused to be served on the owners of the lands and premises known as "The Old Presbyterian Church" at 7788 Yonge Street, Thornhill, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and,

WHEREAS the Conservation Review Board has held a hearing to determine whether the property in question should be designated and reported its findings of fact and recommendations to the Council; and,

WHEREAS the Council has considered the report of the Conservation Review Board;

THEREFORE The Corporation of the Town of Vaughan ENACTS AS FOLLOWS:


1. There is designated as being of architectural and historical value or interest the real property known as "The Old Presbyterian Church" at 7788 Yonge Street, Thornhill, more particularly described in Schedule "A" attached hereto.
2. The Town solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
3. The Town Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the

municipality once for each of three consecutive weeks.
