Notice of Passing of By-law

Take Notice that the Council of the Town of Vaughan has passed By-law  
Number 83 to designate the following property, including lands and  
building, as being of architectural and/or historical value or interest  
under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337:

"The J.E.H. MacDonald House"  
121 Centre Street, Thornhill  
Part of Lot 30, Concession 1

Reasons for the Proposed Designation

The J.E.H. MacDonald House is recommended for designation on archi-  
tectural and historical grounds. The house was designed by, and  
built for, the noted Group of Seven artist J.E.H. MacDonald in 1914  
where he lived with his family until his death in 1932. Built in  
the vernacular Ontario Classic style with a bargeboard-decorated  
centre gable and a balanced arrangement of door and window openings,  
this clapboard house has been designed so as to blend into the four  
acre forested lot on which it sits.

THE CORPORATION OF THE TOWN OF VAUGHAN

BY-LAW NUMBER 21-83

A By-law to designate the property known as Centre Street, Thornhill, as being of architectural and historical value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS the Council of The Corporation of the Town of Vaughan has caused to be served on the owners of the lands and premises known as "The J.E.H. MacDonald House" at 121 Centre Street, Thornhill, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and,

WHEREAS the Conservation Review Board has held a hearing to determine whether the property in question should be designated and reported its findings of fact and recommendations to the Council; and

WHEREAS the Council has considered the report of the Conservation Review Board;


THEREFORE The Corporation of the Town of Vaughan ENACTS AS FOLLOWS:

1. There is designated as being of architectural and historical value or interest the real property known as "The J.E.H. MacDonald House" at 121 Centre Street, Thornhill, more particularly described in Schedule "A" attached hereto.
2. The Town Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.

3. The Town Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.
