THE CORPORATION OF THE TOWN OF VAUGHAN

BY-LAW NUMBER 29-85

A By-law to designate the property known municipally as 10101 Keele Street, Maple, in the Town of Vaughan, Regional Municipality of York, as being of architectural and historical value or interest.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and,

WHEREAS the Council of The Corporation of the Town of Vaughan has caused to be served on the owners of the lands and premises known as St. Stephens Anglican Church at 10101 Keele Street, Maple, being Part of Lot 21, Concession 3, in the Town of Vaughan, Regional Municipality of York, more particularly described in Schedule "A" hereto; and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality once for each of three consecutive weeks; and,

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality:


NOW THEREFORE the Council of The Corporation of the Town of Vaughan ENACTS AS FOLLOWS:

1. There is designated as being of historical and architectural value or interest the real property known as St. Stephens Anglican Church, situated at 10101 Keele Street, Maple, being Part of Lot 21, Concession 3, in the Town of Vaughan, in the Regional Municipality of York, more particularly described in Schedule "A" attached hereto.
2. The reasons for the designation are set out in Schedule "B" attached hereto.
3. The Town Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A", attached hereto, in the proper land registry office.

4. The Town Clerk is hereby authorized to cause a copy of this By-law to be served on the Owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper in which notice of intention to so designate was published once for each of three consecutive weeks.

SCHEDULE "A" TO BY-LAW 29-85

DESCRIPTION OF LANDS

ALL AND SINGULAR that certain parcel or tract of land and premises situate lying and being in the Town of Vaughan and the Regional Municipality of York, being composed of Lots 7, 8, Part of 9 and Part of Lane, as shown on a plan registered in the Registry Office for the Registry Division of York Region (formerly the Registry Division of the East and West Riding of the County of York) as Number 72, which said parcel may be described as follows:

COMMENCING at the northwest angle of said Lot 8;

THENCE easterly along the northerly limit of said Lot 8, along the northerly limit of said lane and along the northerly limit of said Lot 9, in all a distance of 278 feet 10 3/4 inches more or less to the northeast angle of said Lot 9;

THENCE southerly along the easterly limit of said Lot 9 a distance of 99 feet 4 inches more or less to its intersection with the line between the north and south halves of said Lot 9;

THENCE westerly along the line between the north and south halves of said Lot 9 to the westerly limit thereof and continuing westerly in a straight line to the southeast angle of said Lot 7 and continuing westerly along the southerly limit of said Lot 7, in all a distance of 278 feet 10 3/4 inches more or less to the wouthwest angle of said Lot 7;

THENCE northerly along the westerly limits of said Lots 7 and 8 being along the easterly limit of Keele Street, 99 feet 4 1/2 inches more or less to the point of commencement.

REASONS FOR DESIGNATION

St. Stephen's Anglican Church is recommended for designation for historical and architectural reasons. It was built in a vernacular Gothic Revival style inspired by the rural English churches of the 13th century. Characteristic features include the lancet-arched windows, brick buttresses and its rectangular plan with a projecting entry porch and polygonal chancel.

St. Stephen's was originally located on Lot 10 in the 3rd concession of Vaughan Township. The congregation was moved to Maple in 1895 in order to be closer to its parishioners. An outgrowth of the MacKenzie Rebellion, St. Stephen's remains a small but dedicated congregation.
