


The Council of The Corporation of the Town of Vaughan ENACTS AS

READ a FIRST and SECOND time this 10th day of June, 1985.






IN THE MATTER OF an application by Bryan K. Spencer to the Council of the Corporation of the Town of Vaughan dated January 30th, 1984, for permission to demolish all buildings situated at 8934 Huntington Road, Nashville/Kleinburg, Ontario.
