NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Vaughan intends to designate the property, including lands and buildings, known municipally as 82 Monsheen Ave., Woodbridge in the City of Vaughan, Regional Municipality of York, Ontario, as a property of architectural and/or historical value or interest under Part IV Of The Ontario Heritage Act, R.S.O. 1990, c.0.18. s.29:

SHORT STATEMENT OF THE REASONS FOR DESIGNATION

The Stanley B. Barclay House, known municipally as 82 Monsheen Drive, Woodbridge has design and architectural value as a representative example of the Canadian regional variant of the 1950's modern style. The property also has associative value through its connection to the prominent Modernist architectural firm Fleury, Arthur, Barclay and Stern (1949-1965) and its connection to modern architectural design ideas exemplified by the Canadian Trend House program. The property has contextual value as a part of the Seneca Heights subdivision development, and as an indicator of the post-war growth of the Village of Woodbridge. The subject property is also physically, functionally and visually linked to its location on the Humber River ravine.

Any person may, within thirty days of the 5th day of November, 2011, being the first publication of this Notice, send by registered mail or delivered to the Clerk of the City of Vaughan, notice of his or her objection to the proposed designation with a statement of the reasons for the objection and all relevant facts. If such Notice of Objection is received, the Council of the City of Vaughan shall refer the matter to the Conservation Review Board for a hearing.
